SUBJECT: SUMMARY OF THE MARCH 26, 2003, MEETING WITH DETROIT
EDISON CO. TO DISCUSS FERMI PERFORMANCE

On March 26, 2003, a public meeting was held at the Monroe County Commissioners Chambers, Monroe, Michigan, between the Nuclear Regulatory Commission (NRC) and Detroit Edison Co. staff. The purpose of the meeting was to discuss NRC's assessment of Fermi's performance for the period of January 1, 2002, through December 31, 2002.

During the NRC presentation, an overall assessment of Fermi performance was provided. As explained in the Annual Assessment letter from NRC to Mr. William O'Connor, Jr., Vice President Nuclear Generating, Detroit Edison Co., dated March 4, 2003, reference ADAMS accession number ML030640369, Fermi 2 operated in a manner that preserved public health and safety and fully met all cornerstone objectives. The slides presented that evening by the NRC are available in ADAMS (accession number ML030920474).

Before adjourning the meeting the NRC provided the opportunity for members of the public to ask questions.
