| Application Period (the "Agreement") with the Official Committee of Unsecured Creditors of |
| Pacific Gas and Electric Company (the "Committee"). The Agreement calls for a monthly |
| fee of \$250,000.00 for the first six (6) months of the Engagement Period and a monthly fee of |
| \$200,000.00 for each month of the engagement after, plus reimbursement of actual out-of- |
| pocket expenses. The total fees incurred March 1 through March 31, 2003 represent 1 month |
| of the monthly engagement during the Application Period. These fees and expenses break |
| -down as follows: |
