This is in response to your October 30, 2002 e-mail to Mr. Paul Goldberg regarding the possibility of the "U.S. Nuclear Regulatory Commission (NRC) looking into a National license for portable gauges that would be valid in all States and territories" and the names of contacts within NRC to work with you on your request.

As you know, NRC has relinquished, with State agreement, its regulatory authority over certain radioactive materials in some States under the authority of the Atomic Energy Act. Under the Agreement State program, States have flexibility to set fee structures, reciprocity, licensing and other requirements for the use of radioactive materials within their jurisdiction and State's requirements may vary from NRC's and from State-to-State. Therefore, the information provided here applies only to petitioning the NRC to consider your suggestion.

Before filing a petition for rulemaking, you may consult with the NRC by writing to: Chief, Rules and Directives Branch, Division of Administrative Services, Office of Administration, U.S. Nuclear Regulatory Commission, Washington, DC 20555-0001; or by calling the Rules and Directives Branch at 301-415-7163 or 800-368-5642, extension 7163.

The NRC is permitted to describe the procedure and process for filing and responding to a petition for rulemaking; to explain an existing NRC regulation and the basis for the regulation; and to assist you to clarify a potential petition so that the Commission is able to understand the nature of the issues of concern to you.

Your petition must, as a minimum, set forth a general solution to the problem or present the substance or text of any proposed regulation, or amendment, or specify the regulation that is to be revoked or amended. It should clearly and concisely state your grounds for, and interest in, the action requested and include a supporting statement for the petition setting forth the specific issues involved and your views, or arguments, with respect to those issues. It should include relevant technical, scientific, or other data that is reasonably available to you in addition to any other pertinent information supporting the action sought.

The detailed requirements for submitting a petition are found in NRC's regulations at 10 CFR 2.802.
