INSPECTION, THE BABCOCK AND WILCOX OPERATOR SHARED ITS
FACILITY RECORDS WITH THE IAEA. AT THE END OF THE
INSPECTION, THE IAEA ASKED THAT THE RECORDS BE SENT TO
THE IAEA. THESE RECORDS WERE SENT VIA DIPLOMATIC POUCH,
REGISTRATION NUMBER >120648, TO THE MISSION ON NOVEMBER 8,
1996. THESE DOCUMENTS ARE CLASSIFIED CONFIDENTIAL NATIONAL
SECURITY INFORMATION.

2. THE FIRST MONTHLY IAEA INSPECTION OF THE BABCOCK AND WILCOX NAVAL NUCLEAR FUEL DIVISION DOWNBLENDING FACILITY OCCURRED OCTOBER 14 THROUGH 18, 1996. DURING THE INSPECTION, THE BABCOCK AND WILCOX OPERATOR SHARED ITS FACILITY RECORDS WITH THE IAEA. AT THE END OF THE INSPECTION, THE IAEA ASKED THAT THE RECORDS BE SENT TO THE IAEA. THESE RECORDS WERE SENT VIA DIPLOMATIC POUCH, REGISTRATION NUMBER 7120648, TO THE MISSION ON NOVEMBER 8, 1996. THESE DOCUMENTS ARE CLASSIFIED CONFIDENTIAL NATIONAL SECURITY INFORMATION.

3. THE MISSION IS DIRECTED TO PROVIDE THE DOCUMENTS CONTAINED IN THE AFOREMENTIONED DIPLOMATIC POUCH TO APPROPRIATE IAEA OFFICIAL.
