Dear Dr. Brocoum:

In its various comments to the Department of Energy (DOE), the U.S. Nuclear Regulatory Commission had expressed concerns related to the use of the "tripartite" probability. Specifically, the NRC was concerned because the probability function, as expressed in the various DOE documents, did not appear to be sufficient to address NRC regulatory concerns. In its response to NRC Comment 1 on DOE Study Plan 8.3.1.8.1.2 (Brocoum to Holonich, 08/11/95), DOE agreed to change the form of the probability function used to assess volcanic hazards into one which the staff considers is better able to address NRC concerns. Therefore, the NRC considers that Comment 1, Study Plan 8.3.1.8.1.2, and Comment 8, Study Plan 8.3.1.8.1.1, are resolved. In addition, Concern 2 (Holonich to Shelor, 08/18/93), has also been satisfactorily resolved.
