


The purpose of this mod is to exercise option period 1 for the remaining months for CLIN 4 and for 2 months for CLIN 16. Option Period 1 is exercised at the prices set forth on the attached OF 336. In addition, Section C.15 entitled Duration of Contract is added to this contract and reads as follows, "The contract commenced on June 28, 2002 and will expire on November 30, 2003 for CLIN 4 and on May 31, 2003 for CLIN 16. The contract total price is increased by \$215,102.80 from \$305,589.30 to \$520,692.10.
