The purpose of this contract modification is to exercise option period 2 for a period of two add'l months. Accordingly, the contract is modified as follows: In accordance with Section I.2, option period 2 is hereby exercised at the prices set forth in the attached OF 336. The total firm fixed price of the contract is increased by \$48,722.38 from \$389,135.65 to \$437,858.03. Section B.4 is changed to read "The firm fixed price of this contract is \$437,858.03." Section F.2 of this contract is changed to read, "The contract shall commence on June 18, 2001 and will expire on May 17, 2003. The term of the contract may be extended at the option of the Government for a 6 month period and two one-year option periods."

All other terms and conditions remain unchanged.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
