


The purpose of this modification is to: (1) obligate funding in the amount of \$538.00 to cover costs under Modification No. 4 as the result of DCAA's approved provisional billing indirect cost rates for FY 2003; (2) provide additional funding per the Limitation of Cost clause; (3) extend the expiration date of the contract until July 30, 2003; (4) increase the contract's ceiling amount by \$156,657.00 from \$655,512.81 to \$812,169.81; (5) increase the contract's obligated amount by \$94,538.00 from \$655,512.81 to \$750,050.81; (6) revise the deliverable schedule; and (6) incorporate FY 2003 provisional billing indirect cost rates under the contract. Accordingly, the contract is hereby modified as follows:

1. Under Subsection B.3, "CONSIDERATION AND OBLIGATION—COST PLUS FIXED FEE (JUN 1988) ALTERNATE I (JUN 1991), paragraphs (a), (c), and (d) are DELETED in their entirety and SUBSTITUTED with the following in lieu thereof:

"(a) The total estimated cost to the Government for full performance of this contract is \$812,169.81 of which the sum of \$768,763.30 represents the reimbursable costs, and \$43,406.51 represents the fixed fee."

"(c) The amount obligated by the Government with respect to this contract is \$750,050.81, of which the sum of \$706,644.30 represents the reimbursable costs, and of which \$43,406.51 represents the fixed fee."

"(d) It is estimated that the amount currently allotted will cover performance through through April 30, 2003."

2. Under Modification No. 2, Statement of Work, Section VI entitled "DELIVERABLES AND DELIVERY SCHEDULE," change the due dates for the deliverables listed below :

The draft final NUREG-1640, Volume 1 shall be due April 30, 2003.

The appendices for draft final NUREG-1640, Volume 2 shall be due May 31, 2003.

The Engineering Design Files, complete with virus-free, electronic copies of the spreadsheets workbooks, as appropriate, shall be due July 30, 2003.

Edited excel workbooks, in a electronic format, and a User's Manual, in both electronic and hard copy formats, shall be due July 30, 2003.

3. Under Subsection F.5, "DURATION OF CONTRACT PERIOD (MAR 1987)," the expiration date is extended from "May 31, 2003" to "July 30, 2003."

4. Under Subsection G.3 entitled "INDIRECT COST RATES (JAN 1993)," paragraph (a) incorporate the provisional billing indirect cost rates for FY 2003. Therefore, paragraph (a) is revised to read as follows:
