YMQAD at REECo in Las Vegas, Nevada, February 4-11, 1991. This surveillance
was conducted to determine compliance with REECo procedures implementing
Criteria II with regard to development and conduct of training [Quality
Procedure (QP) 2.4, Indoctrination And Training] and the qualification and
certification of personnel to perform quality-affecting activity (QP 2.2,
Personnel Qualification and Certification).

Based on the objective evidence examined during the surveillance, four
