Dear Mr. Chairman:

I am responding on behalf of the Nuclear Regulatory Commission (NRC or the Commission) to your letter of May 7, 2003, regarding lessons learned following the discovery of degradation of the reactor pressure vessel head at the Davis-Besse Nuclear Power Station. You expressed concerns that not all internal weaknesses that prevented the NRC from identifying the degradation at Davis-Besse have been completely identified. In your letter, you asked the Commission to provide responses to six questions to assist you in carrying out your oversight and legislative responsibilities.

Since the discovery of degradation of the reactor pressure vessel head at Davis-Besse, the NRC has conducted an extensive review of its regulatory processes in order to identify weaknesses. A Lessons Learned Task Force was formed and chartered to review five general areas: (1) reactor oversight process issues; (2) regulatory process issues; (3) research activities; (4) international practices; and (5) the NRC's Generic Issues Program. A team of NRC's senior managers reviewed the Task Force's recommendations and developed an overall plan to address the weaknesses. Action plans were developed to address the high-priority items: (1) assessment of stress corrosion cracking; (2) assessment of the operating experience program, including integration of operating experience into training and a review of program effectiveness; (3) evaluation of inspection, assessment, and project management guidance; and (4) assessment of barrier integrity requirements.

The NRC has undertaken a critical and extensive review of its processes and is taking actions to correct weaknesses. The regulatory process is dynamic and is continuously being improved as new information is identified. Continuous improvement is necessary for the NRC to meet its primary obligation to ensure the adequate protection of public health and safety.

Your letter also describes a February 20, 2003, memorandum from Mr. Steven Long to each Commissioner. In his memorandum, Mr. Long explains the reason for his dissent from the NRC's decision not to order the Davis-Besse plant to shut down for inspection by December 31, 2001. The NRC encourages its staff to raise safety concerns and express their views on important technical issues because a diversity of opinions improves the decision-making process. However, while we encourage and appreciate the expression of Mr. Long's viewpoint, his opinions are not necessarily shared by other engineers and risk analysts. While the NRC values Mr. Long's views, it also values the views of the rest of the staff.

Question 1:

Please provide all records relating to the consideration and final decision by NRC not to issue a shutdown order at Davis-Besse.

Response 1:

Enclosure 2 is a list of records which were previously provided to Congress in response to a similar request. In addition, listed below are four new records. Copies of these new records are provided in Enclosure 3.

Question 2:

Please review the February 20, 2003, memorandum from Steven M. Long to the Commission and provide me with a full explanation on each point raised in that memorandum.

Response 2:

The first point Mr. Long raised in his memorandum was his interpretation of the “vote” or “show of hands” that occurred in the November 28, 2001, staff meeting held in our Office of Nuclear Reactor Regulation (NRR). The purpose of this meeting was to discuss the technical merits of FirstEnergy Nuclear Operating Company’s (FENOC’s) proposal to continue operation of the Davis-Besse plant until February 16, 2002. There were a number of technical staff involved in this issue, who were present in the meeting, including materials engineers and risk analysts. Members of NRR management were also present since a decision needed to be made in the near future. The senior NRR manager at the meeting first asked everyone for their opinion of whether there was a date beyond which plant operation would not be acceptable. Contrary to Mr. Long’s memorandum, this was not a “vote,” but rather a solicitation of technical opinions from the various staff members in order to determine the extent of consensus on this question. Extensive technical discussion ensued. Several staff recommended that the plant shut down by December 31, 2001. Other staff argued that the plant could safely operate up to its originally proposed shutdown date of March 31, 2002. Still others believed that the analyses and data were not accurate enough to establish a shutdown date.

Realizing that there was no staff consensus on the question of a particular shutdown date, the senior NRR manager initiated a discussion as to whether any of the staff believed that a loss of coolant accident due to ejection of a control rod drive mechanism (CRDM) was likely to occur before February 16, 2002. This was important because the need to shut down and inspect was to assure that this kind of an event was very unlikely. In response to this question, all staff at the meeting agreed that a loss-of-coolant-accident (LOCA) occurring due to a CRDM ejection was unlikely. In other words, while some staff would have preferred an earlier shutdown (December 31, 2001) and other staff thought a later shutdown (March 31, 2002) was acceptable, none of the staff expressed a significant safety concern with FENOC’s proposal to operate until February 16, 2002.

Contrary to Mr. Long’s memorandum, there was no “voting” process used during the November 28, 2001, staff meeting. Based on unanimous agreement by the staff in the meeting that operation of Davis-Besse through February 16, 2002, did not pose a significant safety concern, the senior manager informed the Director of NRR that the staff could accept FENOC’s proposal to operate up to February 16, 2002, and that issuance of a shutdown order was not necessary. The unanimity of the staff’s decision in this regard was substantiated by the Office of the Inspector General’s (OIG) report dated December 30, 2002.

The following day, the Director of NRR, who had the authority to issue the order, met with the staff members who favored an earlier shutdown to learn whether they were comfortable with the outcome of the meeting. These individuals were again provided the opportunity to express their safety concerns and provide input to the decision. The individuals stated that they were comfortable with the decision that had been reached. This was confirmed by the OIG through conversations with the individuals and is documented in its report.

The second point Mr. Long made was that “...if the analysis that was used to estimate the risk for the first 47 days of 2002 was also applied to the prior 150 days since the bulletin [Bulletin

2001-01] was issued, the December 31 date would not have been justified by this guidance.” Based on this result, Mr. Long questioned the validity of the original December 31, 2001, target date for completion of inspections by all licensees. The NRC, however, had determined that based on engineering judgment, the December 31 target date was appropriate.

In November 2001, the decision before the NRC was whether Davis-Besse could deviate by 47 days from the Bulletin 2001-01 target date of December 31, 2001. Therefore, the risk involved in the decision was the risk associated with 47 days of continued operation to February 16, 2002.

The thought process presented in Regulatory Information Summary (RIS) 2001-02 for risk-informed regulatory decision making was appropriately applied in this decision. The data presented by FENOC and the independent calculations performed by the staff concluded that the increased risk of core damage was small and the risk of a large early release of radioactive material was very small. The analysis concluded that the results were considered as “small changes, acceptable with management attention,” in accordance with the guidelines identified in Regulatory Guide 1.174. Management attention was provided throughout the process.

Mr. Long’s third point was that the NRC has not adopted a numerical value of risk that constitutes “adequate protection.” Mr. Long inferred that such a limit must be greater than 1E-4 per reactor-year.¹ Based on this inference, he postulated that the NRC would find two CRDM nozzle ejections per year across the industry to be acceptable.

Rather than adopt a numerical risk threshold for adequate protection, the NRC adopted a process that is described in RIS 2001-02 for determining adequate protection in a risk-informed way. In the process, the five attributes of risk-informed decision making are examined: 1) compliance with current regulations, or alternative approval; 2) defense in depth; 3) maintenance of sufficient safety margins; 4) minimizing changes in risk; and 5) the ability to monitor the effects of a risk-informed decision. The guidelines for acceptable change in core damage frequency due to a decision based on this process is 1E-5 per reactor-year.² Application of that process in the case of Davis-Besse concluded that a nozzle ejection during the brief period of extended operation was very unlikely.

Finally, Mr. Long commented on the legal basis necessary for issuing an order. He stated that it was his “...position that, in this type of situation, the agency has the legal discretion to use its judgment to issue an order....” This comment is similar to Finding 4 in the OIG’s report.

Former Chairman Meserve, on behalf of the Commission, responded to the OIG’s finding in his January 8, 2003, memorandum. The Chairman stated that a regulatory foundation for ordering the plant [Davis-Besse] to shut down clearly existed, and the order would have been issued if FENOC had not provided sufficient safety justification for an alternate inspection date.

Question 3:

Please describe the administrative procedures or other guidelines for NRC staff adopted by the Commission and used for developing final recommendations or determinations on significant safety matters including shutdown orders and other significant risk determinations used in regulatory actions.

Response 3:

The Division of Licensing Project Management (DLPM) in NRR has a handbook (DLPM Handbook) that provides guidance on NRC regulations, procedures and documents in order to help its employees complete various licensing actions and tasks. There are separate sections for license amendments, American Society of Mechanical Engineers (ASME) Code relief requests, exemptions to the regulations, license transfers, and issuance of orders, among other topics.

The section on orders describes three situations where orders are typically issued. These situations are:

when the NRC has identified deliberate misconduct that may cause a licensee to be in violation of an NRC requirement,

where incomplete or inaccurate information is deliberately submitted to the NRC, or

where the NRC loses its reasonable assurance that the licensee will meet NRC requirements.

One of the references in the handbook is to Title 10 of the *Code of Federal Regulations*, (10 CFR) Section 2.202, "Orders." The regulation describes the requirements for an order including specifying the action proposed and the basis for taking it, the response required, and the right to request a hearing. In addition to the above situations, 10 CFR 2.202 also states that the Commission can issue an order if potentially hazardous conditions or other facts deemed to be sufficient grounds for an order exist.

NRR has an Office Instruction, ADM-200, "Delegation of Signature Authority" (ADAMS Accession No. ML030070286), which describes the level of authority required to sign all agency documents that are issued by NRR. In general, as document importance increases, a higher level of authority is required to sign the document. This ensures an appropriate level of management review before issuance of each type of document. If the staff believes that ordering the licensee to take certain actions is appropriate, then the staff's position would be reviewed by NRR management through the Director of NRR, because the Director has signature authority for orders.

Question 4:

Please describe the voting process utilized by NRC staff and how this voting process was consistent with administrative procedures or guidelines with respect to the decisions on the proposed shutdown order for Davis-Besse and the December 4, 2001, acceptance of FirstEnergy's bulletin response.

Response 4:

As explained in Response 2, there was no "vote" taken at the November 28, 2001, staff meeting. Rather, the staff was asked to indicate its opinion regarding the issuance of an order to determine if a staff consensus existed.

The staff does not use a "voting process" for making decisions. Instead, the process is one in which the technical staff tries to reach consensus which usually results in a single staff recommendation being made to NRC management.

In the event that a consensus cannot be reached, management will seek out and listen to alternative viewpoints. Management considers the staff's recommendations, especially if alternative views exist, in order to assess whether the recommendations can withstand technical and legal scrutiny and are consistent with NRC policies and procedures. Ultimately, management will make a decision after considering all input and viewpoints.

The administrative procedures and guidelines for developing recommendations and determinations used in regulatory actions are described in Response 3.

Question 5:

Please provide a full explanation on why the absence of adequate inspection data on the reactor vessel head from the 1998 and 2000 outages was acceptable to NRC staff in the risk assessment and regulatory decision-making process, and to what degree the absence of this data was a factor in the risk assessment and regulatory decision making process.

Response 5:

FENOC provided the staff with inspection data of the reactor vessel head collected during outages in 1996, 1998, and 2000. It submitted the data to support, in part, a risk-informed basis for continued operation in response to NRC Bulletin 2001-01. The staff's discussions with FENOC in late November 2001 produced evidence that the inspections gave varying levels of assurance that cracking was not occurring in the nozzles. Most of the nozzles had been inspected at least once, and a majority had been sampled on more than one occasion. The nozzles that were not inspected were claimed by the licensee to be less susceptible to circumferential cracking because of their location.

Upon review of this information, and after viewing videotapes provided by FENOC from the prior inspections in 1996 and 1998, the staff concluded that, while the 1996 inspection was a fairly complete visual inspection of the head, the 1998 inspection was more limited in scope and quality because of the presence of boric acid deposits, which FENOC indicated were the result of CRDM flange leaks. FENOC further stated that the inspection conducted in 2000 was less effective, again because of the presence of boric acid deposits. Therefore, the staff did not give FENOC credit for the 1998 and 2000 inspections in the risk analysis. In other words, the staff did not find the 1998 and 2000 inspection data to be acceptable.

Based on experiential evidence gathered from inspections at other plants, such as Oconee Units 2 and 3 and Crystal River, Unit 3, there was no reason to expect that a corrosive environment could exist under the operating conditions at the reactor vessel head. Any reactor coolant that leaked from a nozzle or flange was thought to evaporate immediately at those high temperatures, leaving only a non-corrosive boric oxide powder.

The flanges above the Davis-Besse reactor vessel were known to leak. FENOC initiated corrective action to replace or repair a number of flanges each outage. The boron that obscured visual inspection of portions of the head was thought to have resulted from this flange leakage. FENOC stated to the staff that inspection results showed no evidence attributable to CRDM leakage due to nozzle cracking.

In a series of written submittals and presentations at NRC headquarters between October 2, 2001, and November 30, 2001, FENOC provided analyses of the frequency of a postulated Loss of Coolant Accident (LOCA) as a result of CRDM nozzle ejection and by circumferential cracking. It proposed a set of interim compensatory measures to mitigate the additional risk associated with the increased LOCA frequency. First, FENOC moved its shutdown date forward from March 31, 2002, to February 16, 2002. They also committed to lower the operating temperature of the upper head from 605° F to 598° F. However, this reduction in temperature was estimated to represent a very small decrease in the growth of any axial or circumferential cracks that might exist. In addition, FENOC proposed actions to increase the

reliability of emergency core cooling systems in the event of a CRDM nozzle ejection. These actions included the use of a dedicated operator to perform a number of manual actions outside of the control room, which are required for switch-over to the recirculation mode of the emergency core cooling system (ECCS) in the event of a LOCA. Failure of switch-over is a principal contributor to ECCS failure in the Davis-Besse probabilistic risk assessment. Other precautions to maximize the availability of ECCS equipment were included in FENOC's commitments. These compensatory measures were documented in a letter dated November 30, 2001. FENOC provided estimates of the changes in the probability of core damage and large early release due to those compensatory actions.

The NRC staff reviewed the base case risk calculations provided in FENOC's November 1, 2001, submittal and in subsequent presentations, and performed sensitivity analyses to determine the effect of prior inspections on risk. The staff also considered FENOC's evaluation provided in support of the interim compensatory measures. The staff estimated that, giving credit only for the inspection in 1996, the probability of a nozzle ejection during the period of operation from December 31, 2001, to February 16, 2002, was in the range of $2E-3$ per reactor-year. This probability represented an increase in overall LOCA probability for the plant. The increase in core damage probability and large early release probability were estimated as approximately $5E-6$ per reactor-year and $5E-8$ per reactor-year, respectively.

The staff concluded that a LOCA due to CRDM nozzle ejection during the period of operation from December 31, 2001, to February 16, 2002, was unlikely and, given the conditional core damage and containment failure probabilities for such an event, the overall risk increase would be small. This conclusion was based on the weight of evidence, including the structural margins to failure in CRDM nozzles with identified circumferential cracks at other plants, a comparison of operating time for Davis-Besse compared with other plants of similar designs, the favorable inspection results from the 1996 outage, and the staff's review of probabilistic safety assessment calculations submitted by the licensee.

The staff concluded that the small increase in LOCA probability, the low conditional core damage probability, and the low conditional containment failure probability meant that defense-in-depth was preserved, although leakage from the reactor coolant pressure boundary was likely. The staff further concluded that, while the structural margins of some CRDM nozzles were believed to be reduced, sufficient margin remained to maintain safety and prevent a LOCA. The staff concluded that the change in core damage frequency due to the potential for CRDM nozzle ejection was consistent with the guidelines of RG 1.174.

Based on experiential evidence gathered from inspections performed at numerous other plants, the staff had no reason to believe that a corrosive environment existed. The decision to allow Davis-Besse to continue to operate until February 16, 2002, was based on the existence of substantial margin of safety, defense-in-depth, unlikelihood of CRDM nozzle ejection, experiential evidence, and engineering judgment.

Question 6:

Why did NRC staff fail to complete, before December 4, 2001, the documented safety rationale to support its December 4, 2001, decision to allow Davis-Besse to operate until February 16, 2002?

Response 6:

The purpose of the NRC's December 4, 2001, letter to FENOC was to formally document the conclusion of the staff's interactions with FENOC to determine if a technical basis existed for Davis-Besse to operate beyond the December 31, 2001, target date (contained in the NRC's Bulletin 2001-01) for completion of inspections. The process followed in the staff's interaction with FENOC was an open one wherein the staff challenged FENOC in a number of public meetings and in correspondence regarding its technical bases. The NRC's December 4, 2001, letter referred to these various meetings and correspondence to, in part, provide the technical basis for the conclusion that Davis-Besse could operate until February 16, 2002, and not until March 31, 2002, as originally requested. The letter also stated that the staff's assessment regarding closeout of Bulletin 2001-01 would be forwarded under separate correspondence in the near future. This assessment was not issued until December 3, 2002. The staff's failure to provide this documentation in a timely manner resulted primarily from a failure to track the commitment. Also contributing to this oversight was a heavy workload during this time period that included closeout of Bulletin 2001-01 for other plants and development of an action plan to address the control rod drive nozzle cracking issue.

By memorandum dated December 30, 2002, the OIG issued a report regarding NRC staff's decision to permit Davis-Besse to operate until February 16, 2002, which was beyond the December 31, 2001, date in Bulletin 2001-01. The report included five specific findings. In one of the five findings, the OIG found that the NRR staff did not document its analytical bases and conclusions supporting its decision to allow FENOC to operate Davis-Besse until February 16, 2002. In a memorandum to the OIG, dated January 8, 2003, former Chairman Meserve stated, in response to this finding, that the staff should have documented the basis for the decision at an earlier stage.

To address the OIG finding, former Chairman Meserve's memorandum stated, "I have directed the Executive Director for Operations to ensure that actions are taken to ensure that these oversights do not occur again." In response to this directive, the guidance to NRR DLPM project managers on documenting the decision-making process has been updated. The new guidance provides NRC management expectations for project managers to document plant-related issues promptly. The OIG finding relates to a single occurrence of the NRR staff failing to properly document the decision-making process and it is not necessarily indicative of a widespread problem. However, since the requirements for documenting the decision-making process are applicable not only to NRR DLPM project managers, a training package has been prepared and distributed to other NRC offices.
