
SUBJECT: MINUTES OF THE NOVEMBER 14, 1991, QUALITY ASSURANCE MEETING

I am transmitting the enclosed minutes of the November 14, 1991, quality assurance (QA) meeting. The meeting attendees included representatives from the U.S. Nuclear Regulatory Commission (NRC), U.S. Department of Energy (DOE), Nuclear Waste Management System Management and Operating Contractor, State of Nevada, U.S. Geological Survey, and Center for Nuclear Waste Regulatory Analyses.

DOE presented information on the following topics: 1) audit/surveillance schedules; 2) Management and Operations Contractor QA program and transition update; and 3) status of QA procedure consolidation. The NRC staff presented its summaries of observations of the Science Applications International Corporation/Technical & Management Support Services audit (YMP-91-06), U.S. Geological Survey audit (YMP-91-05), Raytheon Services Nevada (RSN) audit (YMP-91-04), Sandia National Laboratories audit (YMP-91-07), DOE Office of Environmental Restoration and Waste Management audit (YMP-91-03), and the RSN surveillance (YMP-SR-91-26).
