The Decommissioning and Regulatory Issues Branch developed and circulated for internal NRC review an earlier version of this BTP in July 1992 to fulfill commitments made in the NRC's Site Decommissioning Management Plan Action Plan. The attached draft BTP has been revised to reflect the comments from this previous internal review, as well as comments we received in November 1994 through a clearance type review.

We intend to distribute copies of the revised draft BTP at the Site Characterization Workshop for Decommissioning, which will be held on November 29 (at Two White Flint North) and 30 (at Holiday Inn-Crowne Plaza), 1994. We also intend to notice availability of the revised draft BTP in the Federal Register in early December. After reviewing the comments on the BTP along with the results of the workshop, we plan to issue a final BTP on site characterization by September 1995.
