Mallinckrodt has requested that NRC release Survey Unit 2501 from licensing controls to accommodate planned renovation of this area. NRC is not prepared to release this area from Mallinckrodt's license at this time. However, NRC has no objection to Mallinckrodt proceeding with the planned renovation of this area. Mallinckrodt should ensure that this area is not recontaminated during future decommissioning activities through effective implementation of the Radiation Protection Program. Mallinckrodt should include FSS results for Survey Unit 2501 in its demonstration that the site meets the criteria established in 10 CFR Part 20, Subpart E, at the time of license termination.

Mallinckrodt should ensure that the debris from renovation of this area is disposed of in a manner which is consistent with Chapter 3 of the approved DP.
