SUBJECT: PROPOSED CHANGES TO FORMAT AND CONTENT OF STUDY PLANS

This letter responds to your letter to me, dated July 15, 1992, concerning the changes the U.S. Department of Energy (DOE) proposed to the format and content of the Site Characterization Plan Study Plans in its letter dated July 8, 1992. In particular, I am responding to your statement concerning the deletion from the Study Plans of references to quality assurance (QA) controls.

DOE has committed to the NRC, in its Office of Civilian Radioactive Waste Management (OCRWM) Quality Assurance Requirements Document (QARD), to develop and implement a QA program which meets regulatory requirements. The NRC staff reviewed and accepted the QARD (DOE/RW-0214), Revision 4, in my letter to OCRWM (J. Roberts) dated November 11, 1992. It is not necessary that this commitment be related in each Study Plan. The implementation of QA controls affecting Study Plan activities is verified through NRC staff observations of OCRWM QA audits and surveillances. The deletion of the reference to QA controls from the Study Plans does not diminish, in any way, the DOE commitment to or the NRC verification of these controls.
