Dear Mr. Holonich:

Enclosed with this letter is a controlled copy of Study Plan 8.3.1.15.1.5, Revision 1, "Excavation Investigations", prepared by the U.S. Department of Energy for the Yucca Mountain site. The study plan numbers correspond to the same numbers used in the Site Characterization Plan for the Yucca Mountain site.

Study plans are prepared, reviewed, and approved under Yucca Mountain Site Characterization Office quality assurance procedures. It should be noted that there may be some inconsistencies in the milestone report titles and schedules given in this study plan and those in the Site Characterization Plan and, as such, represent the Department's current plans.

This study plan was submitted to the Yucca Mountain Site Characterization Office for review before the Department of Energy/U.S. Nuclear Regulatory Commission study plan agreement became effective. Therefore, the Department has reviewed the study plan for consistency with the content requirements for study plans, as given in Attachment B to the Summary of the Department of Energy/U.S. Nuclear Regulatory Commission meeting on the Level-of-Detail for the Site Characterization Plan (May 7-8, 1986). No technical procedures will be used in conjunction with this study plan; all work will be documented in scientific notebooks.

The Department noted in its response to Site Characterization Analysis comment 56 that revision 0 of this study plan included a discussion of model validation. That discussion remains unchanged in revision 1.

This study plan is on critical path for Exploratory Studies Facility construction because it will be used to monitor the underground workings as they are completed by the Tunnel Boring Machine. Consequently, the Department requests that the Commission complete its review of this study plan within the 90 days specified in the Department of Energy/U.S. Nuclear Regulatory Commission agreement.
