The findings of readiness reviews at both the Nevada Site and MRS, as well as the M&O readiness reviews (both QA and Management Controls), along with other QA program audits and surveillances, are to be reviewed and evaluated as part of these readiness reviews. Particular attention will be paid to the status of Open Items identified during previous respective readiness reviews.

For your information, Mr. Nat Trembath, of the M&O Contractor, is appointed to serve as Chairman of the Readiness Review Board and Mr. Art Kubo, also of the M&O Contractor, as the Review Team Leader. Enclosed are the schedules for each readiness review and a list of participants (enclosure 3).
