ISSUANCE OF SURVEILLANCE REPORT YMP-SR-93-001 RESULTING FROM YUCCA MOUNTAIN QUALITY ASSURANCE DIVISION (YMQAD) SURVEILLANCE OF EG&G ENERGY MEASUREMENTS, INC. (EG&G/EM)

Enclosed is the report of Surveillance YMP-SR-93-001 conducted by the YMQAD at the EG&G/EM facilities in Las Vegas, Nevada, October 15-16, 1992.

The purpose of the surveillance was to verify that EG&G/EM had developed the procedures required to meet the requirements of the EG&G/EM Quality Program Description for the Yucca Mountain Site Characterization Project and the requirements of the Office of Civilian Radioactive Waste Management Quality Assurance Requirements Document, Revision 4.

Six Corrective Action Requests (CAR) were generated as a result of this surveillance. Responses to the CARs (which were transmitted via separate letter) are due by the date indicated in Block 11 of the CARs. A response to this surveillance report is not necessary.

This surveillance is considered completed and closed as of the date of this letter; however, any open CARs will continue to be tracked until they are closed to the satisfaction of the quality assurance representative and the Director, YMQAD.
