# Early Site Suitability Evaluation (ESSE)

The ESSE effort continues in the external peer review phase. A meeting involving the ESSE staff, portions of the ESSE Core Team, and related portions of the Peer Review Panel was held in San Diego, California, on October 23 and 24, 1991, to discuss the content of the ESSE Report. The meeting is part of an effort to increase the dialogue between reviewers in order to aid the quality and depth of the review.

Remaining ESSE effort this week includes preparations for the comment resolution to follow the peer review and the subsequent publications efforts.

#### B. Environmental Programs

Environmental Compliance and Permitting

No significant new items to report this week.

# C. Field Operations

The Site Manager and the Field Operations staff participated in and provided support for two major tours this week. These were the Northern States Power Group held on October 22, 1991, and a general public Open House and Site Tour held on October 23, 1991. The combined total of personnel for these two tours was approximately 450. Staff is now gearing up for the next general public tour on October 26, 1991. Approximately 400 people are expected.

The Site Manager, with the assistance of the training department, conducted a two-day audit preparation session for the Field Operations Center staff. This session was to prepare for the upcoming quality assurance (QA) audit which will be conducted October 28 through November 1, 1991. Handouts, a video entitled "Say the Right Thing" and briefings by the Site Manager were presented at the audit session.

Progress is underway by Reynolds Electrical & Engineering Co., Inc. (REECo), at Well VH-1. It is anticipated that by October 24, 1991, the chain link fencing, security gate, two storage tanks, and the generator will be in place at the well. This will be completed prior to sampling of the water.

Approximately 300+ specimens were approved for processing and removal. Requesters include the School of Mines, University of Nevada, Reno, Nevada; Nevada Bureau of Mines and Geology; Technical and Management Support Services (T&MSS); and U.S. Geological Survey.

Continued receiving core from UZN55. From October 17-23, 1991, received ten containers consisting of 154.4 feet of core and cuttings. Completed processing of eight containers. Supported visual examination of 24 containers.

# G. Public Outreach and Institutional Activities

A project overview presentation was given on Saturday, October 19, 1991, to the Westminster Men's Club, Las Vegas, Nevada.

The seventh Open House Tour of Yucca Mountain was conducted on Wednesday, October 23, 1991. Approximately 300 people signed up and were given guided tours of the Yucca Mountain Information Office, Las Vegas, Nevada, the Field Operations Center, and Yucca Mountain.

The YMP exhibit was set up and staffed October 19, 1991, for Sandia National Laboratories Open House, in Albuquerque, New Mexico.

A tour to Yucca Mountain was conducted on Tuesday, October 22, 1991, for employees of Northern States Power Company, Minneapolis, Minnesota.

The Project Manager presented a technical project overview to the American Society of Civil Engineers on Thursday, October 24, 1991, in Las Vegas, Nevada.

A staff member represented YMP at a town meeting held in Pahrump, Nevada, to discuss Yucca Mountain. The meeting was organized by the State of Nevada Nuclear Waste Project Office. Approximately 45 people were in attendance, including representatives from the Nevada State Legislature and DOE Field Office, Nevada.

## H. Systems Management and Integration

#### Technical Data Management

The Technical Data Base (TDB) Quarterly Report is in review prior to distribution. Reviews should be complete and the document distributed by the end of this month. The TDB Handbook is nearing completion. The Technical Data catalog has been released and is now in distribution. The final meeting of the Technical Data Advisory Group was held on October 17, 1991. The representatives to that group will continue to be key points of contact on Technical Data Management issues, but the group will be reconfigured into two separate entities. One to consider issues relative to the Reference Information Base; and the other to consider issues relative to development of the project TDB.

# Exploratory Studies Facility (ESF) Task Force Activities

Approval has been received from the Under Secretary to start limited new surface-based testing and to initiate limited Title II Design without a formal Energy Systems Acquisition Advisory Board (ESAAB) review. ESAAB members from EH and PR have concurred.

The ESF engineering plan for Title II Design of the first access site preparation package has been submitted for YMP approval.

# Site Characterization Plan (SCP) Progress Report (PR)

Yucca Mountain Site Characterization Project Office (YMPO) sent a camera-ready copy of PR 4 to the Office of Scientific and Technical Information for duplication and distribution on October 3, 1991. YMPO received input from Los Alamos National Laboratory (LANL), Lawrence Livermore National Laboratory, U.S. Department of Energy/Headquarters (DOE/HQ), and Sandia National Laboratories (SNL) for PR 5. Input from the U.S. Geological Survey is expected by October 22, 1991. Compilation of PR 5 has begun with the input currently in hand.

## SCP Study Plan (SP) Status

The U.S. Nuclear Regulatory Commission (NRC) has completed their Phase 1 acceptance review and found no objections to SP 8.3.1.2.1.3, "Characterization of the Yucca Mountain Regional Ground-Water Flow System."

Comment verification was initiated on revision 1 of SP 8.3.1.4.2.2, "Characterization of Structural Features Within the Site Area."

# Early Site Suitability Evaluation (ESSE)

The ESSE effort continues in the external peer review phase. A meeting of portions of the ESSE Core Team, ESSE staff, and portions of the peer review panel will occur next week in conjunction with the Geologic Society of America meetings in San Diego, California. Remaining ESSE effort involves preparations for the effort to resolve peer review comments and the resulting ESSE report revisions/publication.

of two water storage tanks at the well-head, REECo will commence with the hauling of water from VH1 to the water storage tanks located on the south rim of 40 Mile Canyon. It is anticipated that this water hauling will commence by October 28, 1991.
