Dear Mr. Reamer:

The Yucca Mountain Site Characterization Project (YMP) will hold a Technical Program Review (TPR) the week of February 14-18, 1993, at the Stardust Hotel in Las Vegas, Nevada. This TPR is designed to foster communication and promote understanding among the U.S. Department of Energy (DOE), the Civilian Radioactive Waste Management System Management and Operating Contractor (CRWMS M&O), project participant organizations, and principal investigators in the many YMP disciplines as to technical status, progress, and direction of the investigations and studies in the Site Characterization Plan (SCP). The U.S. Nuclear Regulatory Commission is invited to send a representative(s).

A draft agenda of the meeting is enclosed (enclosure 1). Key topics to be addressed in presentations and discussed in a round-table setting will include aspects of the following:

- 1. Articulation of the SCP's original testing objectives.
- 2. How site characterization investigations and studies have evolved as a result of technological changes and the insights provided by new data.
- 3. Where is the program now positioned with respect to the data needed to assess site suitability.
- 4. When will the program be technologically capable of completing acquisition of the characterization data needed to make regulatory compliance arguments, and what residual uncertainties are there likely to be.
- What inputs are being/are to be supplied for compliance assessment through physical system and total-system performance modeling.
