APPENDIX G

BASIC RIFLE QUALIFICATION COURSE

The maximum score obtainable is 100 points. The minimum score allowable is 80%. A maximum of 20 rounds are fired with a point value of 5 for each round that hits on or inside the silhouette of the FBI-QR target, or similar target using an equivalent scoring method. For both stages of fire the shooter starts with a loaded rifle from a standing position.
