INTRODUCTION

The following provides an analysis of audits, surveillances, and observer reports prepared by the Office of Civilian Radioactive Waste Management (OCRWM), Office of Quality Assurance (OQA). This analysis is used to evaluate the overall effectiveness of CRWM quality program.

Audit bases include the OCRWM DOE/RW-214, Quality Assurance Requirements Document (QARD), the applicable Quality Assurance Program Plan (QAPP), the Quality Assurance Program Description Document (QAPD), and the appropriate quality implementing procedures. No organizations had fully implemented DOE/RW-0333P, Quality Assurance Requirements and Description, in FY-1993.

Audits were conducted in accordance with the OCRWM Quality Assurance Administrative Procedure (QAAP) 18.2, *Audit Program* and surveillances were conducted in accordance with QAAP 18.3, *Surveillance Program*. Significant additional verification activities included the observation of audits and surveillances performed by various affected organizations. The QA Program as described in the QARD, QAPD, affected organizations QAPPs/QAPDs, and applicable implementing procedures has been, for the most part, determined to be satisfactory.

This report provides an overall element-by-element summary of the QA Program status of OCRWM and other affected organizations (Chart 1). A narrative is included in Section II to provide additional insight into verification activities, program applicability, and implementation status. Individual organizations and verification results are also summarized in Section III. (See tables 1 through 13.)

SUMMARY OF QA PROGRAM EFFECTIVENESS

The QA Program as described in the QARD, QAPD, affected organizations QAPPs/QAPDs, and applicable implementing procedures has been, for the most part, determined to be satisfactory. While unsatisfactory elements have been identified, the nature of the conditions did not warrant immediate corrective action of stop work. Impact is minimal at this time. OQA commits to track the status and take appropriate action if so required.

As a result of OQA audit and surveillance activities, forty-five more CARs were issued in FY 1993 against OCRWM and its affected organizations as compared to FY 1992. However, this is not significant because there was an increase in activities during FY 1993 as evidenced by a comparison of the number of affected organizations' QA Program Elements where there was sufficient activities in the QA Elements to allow a determination of program status. In FY 1992, a combination of 69 QA Elements among the affected organizations had insufficient activities to allow a determination of status, compared to 18 in FY 1993.

SECTION II - NARRATIVE DESCRIPTION

OFFICE OF CIVILIAN RADIOACTIVE WASTE (OCRWM)

<u>OCRWM Headquarters</u> - The OCRWM QA Program implementation was determined to be satisfactory except for QA Program element 19 which was not evaluated due to no implementation activity in this area during FY 1993. A total of nine CARs were issued to OCRWM Headquarters during FY 1993. Six CARs have been closed and three CARs (HQ-93-003, HQ-93-004, and HQ-93-007) are pending completion and verification of corrective actions. OCRWM Headquarters has no responsibilities in the QAPD for QA Program Elements 8, 9, 10, 11, 12, 13, 14, 15, and 20 therefore, no verifications were performed in these areas. The OCRWM OQA Yucca Mountain Division has the responsibility for providing auditors to audit OQA HQ for QA Program Elements 2, 16, 17, and 18. See Table 1 for a summary of the OCRWM Headquarters QA Program evaluations.

YUCCA MOUNTAIN SITE CHARACTERIZATION PROJECT OFFICE (YMPO) - The

YMPO QA Program implementation was determined to be satisfactory except for implementation of QA Program Elements 4 and 7 which were determined to be unsatisfactory. A total of eight CARs were issued to YMPO during FY 1993. Two CARs have been closed and six CARs (HQ-93-003, YM-93-042, YM-93-044, YM-93-086, YM-93-087, and YM-93-093) are pending completion and verification of corrective actions. YMPO has no responsibilities in the QARD for QA Program Elements 9, 10, 12, 14, and 19; therefore, no verifications were performed in these areas. The OCRWM OQA Headquarters Division has the responsibility for performing the audit of YMQAD QA Program Elements 2, 16, 17, and 18. See Table 2 for a summary of the YMPO QA Program evaluations.

OTHER AFFECTED ORGANIZATIONS

<u>EM-343</u> - EM-343 QA Program implementation was determined to be satisfactory except for implementation of QA Program Elements 6 and 18 which were determined to be unsatisfactory. Element 15 had no implementation. A total of six CARs were issued to EM-343 in FY 1993. Two CARs (HQ-93-027 and HQ-93-028) are pending evaluation of the EM-343 response, and four CARs (HQ-93-009, HQ-93-010, HQ-93-011, and HQ-93-012) are pending implementation of accepted corrective actions. EM-343 has no responsibilities delineated for QA Program Elements 8, 9, 10, 11, 12, 13, 14, 19, and 20. Therefore, no verifications were performed in these areas. See Table 3 for a summary of the EM-343 QA Program evaluations.

<u>General Atomic (GA)</u> -The GA QA Program implementation was determined to be satisfactory with the exception of QA Program Element 2 which was determined to be unsatisfactory. One CAR was issued to General Atomics during FY 1993. CAR HQ-93-029 is open pending implementation and verification of corrective actions. General Atomics has no responsibilities in the QARD for QA Program Element 20; therefore, no verification was performed in this area. See Table 4 for a summary of the General Atomics QA Program evaluations. 18

Los Alamos National Laboratory (LANL) - The LANL QA Program implementation was determined to be satisfactory except for implementation of QA Program Elements 3, 4, 7, and 13 which were determined to be not implemented. A total of five CARs were issued to LANL during FY 1993. Three CARs have been closed and two CARs (YM-93-049 and YM-93-051) are pending completion and verification of corrective actions. LANL has no responsibilities in the QARD for QA Program Elements 9, 10, 11, 14, and 15; therefore, no verifications were performed in these areas. See Table 5 for a summary of the LANL QA Program evaluations.

Lawrence Livermore National Laboratory (LLNL) - The LLNL QA Program implementation was determined to be satisfactory except for implementation of QA Program Elements 5, 15, and 19 which were determined to be not implemented. A total of one CAR was issued to LLNL during FY 1993. The CAR (YM-93-085) is pending completion and verification of corrective action. LLNL has no responsibilities in the QARD for QA Program Elements 3, 9, 10, 11, and 14; therefore, no verifications were performed in these areas. See Table 6 for a summary of the LLNL QA Program evaluations.

<u>M&O</u> - The M&O QA Program implementation was determined to be satisfactory except for implementation of QA Program Elements 2, 5, and 15 which were determined to be unsatisfactory and implementation of QA Program Elements 4, 7, 8, 10, 11, and 14 which were determined to be not implemented. A total of twenty-four CARs were issued either by OQA HQ (10 CARs) or YMQAD (14 CARs) to the M&O as a result of two audits and eleven surveillances during FY 1993. Thirteen CARs have been closed and eleven CARs (HQ-93-013, HQ-93-014, HQ-93-019, HQ-93-020, YM-93-040, YM-93-066, YM-93-072, YM-93-073, YM-93-074, YM-93-075, and YM-93-089) are pending completion and verification of corrective actions. The M&O has no responsibilities in the QARD for QA Program Elements 9, 12, 13, and 20; therefore, no verifications were performed in these areas.

In addition, on July 15, 1993, CAR YM-93-070 was issued to the M&O based on the OQA Trend Program which indicated an adverse trend (repetitive) regarding implementing procedures not addressing the upper-tier QA Program requirements and implementing procedures that are inadequate or non-existent for Quality Affecting Activities being performed. This CAR is still open and the corrective action completion and verification is still pending.

Audit YMP-93-16 of the M&O scheduled for August, 1993 was postponed to allow the M&O sufficient time to evaluate their program procedures and take appropriate action. The audit was rescheduled to include QA Program Elements 3, 4, 7, 8, 10, 11, 14, 15, 19 and 20.

In September, 1993, due to problems in the Design Control Area, the M&O issued a Design Control Improvement Plan. The OQA took a proactive approach in this instance by participating in the M&O's procedure improvement process associated with procedure development, design control, audits and surveillances. See Table 7 for a summary of the M&O QA Program evaluations. <u>Pacific Northwest National Laboratory (PNL)</u> - The PNL QA Program implementation was determined to be satisfactory except for implementation of Elements 5 and 17 which were determined to be unsatisfactory and QA Element 6 which had no implementation. A total of two CARs were issued to PNL during FY 1993. The two CARs (HQ-93-022 and HQ-93-023) are open pending verification of completed corrective actions. PNL has no identified responsibilities for QA Program Elements 3, 9, 10, 13, 14, and 20; therefore, no verifications were performed in these areas. See Table 8 for a summary of the PNL QA Program evaluations.

<u>Ravtheon Services Nevada (RSN)</u> - The RSN QA Program implementation was determined to be satisfactory except for implementation of QA Program Element 7 which was determined to be marginal. A total of twelve CARs were issued to RSN during FY 1993. Ten CARs have been closed. Two CARs (YM-93-078 and YM-93-079) are pending completion and verification of corrective actions. RSN has no responsibilities in the QARD for QA Program Elements 8, 9, and 20; therefore, no verifications were performed in these areas. See Table 9 for a summary of the RSN QA Program evaluations.

<u>Reynolds Electrical & Engineering Co., Inc.(REECo)</u> - The REECo QA Program implementation was determined to be satisfactory except for implementation of QA Program Element 4 which was determined to be unsatisfactory. A total of eleven CARs were issued to REECo during FY 1993. Eight CARs have been closed. Three CARs (YM-93-055, YM-93-058, and YM-93-061) are pending completion and verification of corrective actions. REECo has no responsibilities in the QARD for QA Program Elements 3, 9, 11, 19, and 20; therefore, no verifications were performed in these areas. See Table 10 for a summary of the REECo QA Program evaluations.

Sandia National Laboratory (SNL) - The SNL QA Program implementation was determined to be satisfactory except for implementation of QA Program Element 4 which was determined to be marginal and QA Program Elements 7, 12, 13, and 15 which had no implementation. A total of nine CARs were issued to SNL during FY 1993. Three CARs have been closed. Six CARs (YM-93-090, YM-93-094, YM-93-095, YM-93-096, YM-93-097, and YM-93-098) are pending completion and verification of corrective actions. SNL has no responsibilities in the QARD for QA Program Elements 9, 10, 11, and 14; therefore, no verifications were performed in these areas. See Table 11 for a summary of the SNL QA Program evaluations.

<u>Science Applications International Corporation (SAIC)</u> -The SAIC QA Program implementation was determined to be satisfactory except for implementation of QA Program Elements 3, 8, and 13 which had no implementation. A total of one CAR was issued to SAIC during FY 1993 and it was subsequently closed. SAIC has no responsibilities in the QARD for QA Program Elements 9 and 11; therefore, no verifications were performed in these areas. See Table 12 for a summary of SAIC QA Program evaluations. <u>U.S. Geological Survey (USGS)</u> - The USGS QA Program implementation was determined to be satisfactory. A total of ten CARs were issued to USGS during FY 1993. Seven CARs have been closed. Three CARs (YM-93-027, YM-93-052, and YM-93-053) are pending completion and verification of corrective actions. USGS has no responsibilities in the QARD for QA Program Elements 3, 9, 10, 11, and 14; therefore, no verifications were performed in these areas. See Table 13 for a summary of the USGS QA Program evaluations. ٦, .
