ISSUANCE OF SURVEILLANCE REPORT YMP-SR-93-043 RESULTING FROM YUCCA MOUNTAIN QUALITY ASSURANCE DIVISION (YMQAD) SURVEILLANCE OF LOS ALAMOS NATIONAL LABORATORY (LOS ALAMOS) AND U.S. GEOLOGICAL SURVEY (USGS) (SCP: N/A)

Enclosed is the report of Surveillance YMP-SR-93-043 conducted by the YMQAD at the Yucca Mountain Site, Los Alamos facilities in Los Alamos, New Mexico, and the USGS facilities in Denver, Colorado, during the period of September 30 through October 26, 1993.

The purpose of the surveillance was to evaluate the control of the Exploratory Studies Facility (ESF) bulk rock samples and core from the surface-based testing program. This surveillance also evaluated the controls established for handling radial borehole core from the ESF.

One Corrective Action Request (CAR) was generated as a result of this surveillance. Response to the CAR (which was transmitted via separate letter) is due by the date indicated in Block 11 of the CAR. A response to this surveillance report is not necessary.

This surveillance is considered completed and closed as of the date of this letter; however, the open CAR will continue to be tracked until it is closed to the satisfaction of the quality assurance representative and the Director, YMQAD.
