Dear Mr. Holonich:

The U.S. Nuclear Regulatory Commission (NRC) provided an evaluation of the Department of Energy's (DOE) December 14, 1990, responses to the 2 objections, 133 comments, and 63 questions in the Site Characterization Analysis (SCA) (NUREG-1347) in an enclosure to a letter dated July 31, 1991. On the basis of the DOE December 1990 responses, NRC closed 59 comments and questions and established the remaining 139 as open items.

During FY 1992, the DOE provided documentation reporting additional information or actions taken toward resolving 24 open items. During FY 1993, the DOE provided similar information on 17 more open items.

Our records show that for FY 1992, the NRC concurred that one open item was resolved. For FY 1993, NRC has concurred upon the proposed resolutions for 18 open items.

Enclosure 1 is a tabulation that reports only the number of open items that DOE has acted upon since December 1990, and the number of open items that NRC has acted upon in the same time frame. Enclosure 2 is a DOE/NRC correspondence log that reports the actions taken with respect to all SCA open items since DOE's December 1990 responses.

We think both compilations will be useful to aid NRC and DOE in verifying their records. We would appreciate confirmation that the reported data is correct or if any discrepancies are present.
