INFORMATION FROM PUBLIC DISCLOSURE (TAC NO. MB7225)

Dear Mr. Coutu:

By your letter dated April 28, 2003, and Westinghouse Electric Company, LLC's (Westinghouse) affidavit executed by H. A. Sepp dated April 28, 2003, you submitted a proprietary document entitled, "Response to [U. S. Nuclear Regulatory Commission] NRC Request for Additional Information (RAI) on Kewaunee Crossflow Ultrasonic Flow Measurement System" and you requested that it be withheld from public disclosure pursuant to 10 CFR 2.790. A nonproprietary copy of this document has been placed in the NRC's public document room and added to the Agencywide Documents Access and Management Systems Publicly Available Records System (ADAMS PARS) Library.

The Westinghouse affidavit stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

- (4)(ii)(a) The information reveals the distinguishing aspects of a process (or component, structure, tool, method, etc.) where prevention of its use by any of Westinghouse's competitors without license from Westinghouse constitutes a competitive economic advantage over other companies.
- (4)(ii)(c) Its use by a competitor would reduce his expenditure of resources or improve his competitive position in the design, manufacture, shipment, installation, assurance of quality, or licensing a similar product.

The NRC staff has reviewed your application and the material in accordance with the requirements of 10 CFR 2.790 and, on the basis of Westinghouse's statements, has determined that the submitted information sought to be withheld contains privileged commercial information and should be withheld from public disclosure.
