## Block 9 (continued) BASIS OF EVALUATION/DESCRIPTION OF OBSERVATIONS:

The purpose of this surveillance was to review the records of YMSCO and Yucca Mountain Quality Assurance Division (YMQAD) DOE personnel's Qualification and Verification of Education and Past Work Experience for compliance and procedure YLP-2-1Q-YMPO, Revision 0, "Yucca Mountain Project Office Qualification and Training."

The following notations are provided relative to the effectiveness of Qualification and Verification of Education and Past Work Experience for YMSCO and YMQAD DOE personnel:

The surveillance was limited to review of Personnel Qualification and Verification of Education and Past Work Experience records for YMSCO and YMQAD DOE personnel only. Records existed only for the time period dating from December 1989 to the present. This surveillance was accomplished by review of actual documentation contained in individual's files.

A checklist was prepared and utilized using YLP-2-1-Q-YMPO, Revision 0, procedural requirements as checklist items. A total of eight YMSCO personnel were selected at random and their personnel files retrieved.

- 1. Position Description and GS numbers were noted.
- 2. Minimum education and experience for these were reviewed using OPM Handbook X-118.
- 3. Education verification documentation was reviewed.
- 4. Experience verification documentation was reviewed.
- 5. Personnel training files were reviewed to reflect verification of education and experience.

All files reviewed were found to be complete and contain the required documentation to support education and position requirements. Currently, only YMSCO DOE personnel have their verifications done in Las Vegas by NVO; YMQAD personnel have their verifications done at Headquarters Quality Assurance Division (HQAD). However, both YMSCO and YMQAD personnel had their verifications done at Las Vegas, NVO prior to System 80 going into effect some three years ago, and these records for both YMSCO and YMQAD are still housed in Las Vegas, NVO. It is recommended that the verification of education and experience records of YMQAD personnel now housed at Las Vegas, Nevada, be sent to HQAD to complement their Official Personnel Folder currently maintained at HQAD (see recommendation). HQAD should maintain these transmitted files in an appropriate file system. In addition, files for future YMQAD personnel should be maintained by HQAD.

## Block 10 (continued) SURVEILLANCE CONCLUSIONS:

The surveillance results determine that the records of YMSCO and YMQAD DOE personnel whose verification of education and experience was performed at Las Vegas, NVO, is complete, on file, readily retrievable and in compliance with YLP-2-1Q-YMPO, Revision 0, Requirements. Requirements relating to YMQAD personnel whose verification of education and experience should be performed at HQAD in the future, needs to be considered by HQAD.

#### RECOMMENDATION:

Officially forward all YMQAD personnel files for verification of education and experience from Las Vegas, NVO to HQAD for retention and control.
