
SUBJECT: REQUEST FOR DOCUMENTS

At the NRC-DOE quality assurance (QA) meeting on January 18, 1995, DOE QA lessons learned and QA program clarification were discussed. DOE noted that, as deemed appropriate, documents titled "Lessons Learned/Program Clarification" have been issued since the Quality Assurance Requirements and Description document (QARD) was published in 1993. The NRC staff has not been on distribution of these documents that can affect the way that the QARD is implemented and the effectiveness of the resultant QA program.
