Enclosed is the report of OCRWM QA Audit YM-ARP-95-09. The audit was conducted by the Yucca Mountain Quality Assurance Division of the Office of Quality Assurance (OQA) in Denver, Colorado, during the period of May 8-12, 1995.

During the course of the audit, the audit team generated two OCRWM Corrective Action Requests (CAR). Responses to the CARs (which were transmitted via separate letter) are due by the dates indicated in Block 13 of the CARs.

Due to the serious nature of the results of this audit, it is requested that USGS management provide the Director, OQA, with a documented plan describing the overall resolution of all the adverse conditions documented in this audit report no later than June 23, 1995. This plan can be separate from the CAR responses.

The audit is considered completed and closed as of the date of this letter; however, any open CARs will continue to be tracked until they have been closed to the satisfaction of the QA representative and the Director, OQA.
