SURVEY REPORT FOR THE U.S. DEPARTMENT OF ENERGY OFFICE OF CIVILIAN RADIOACTIVE WASTE MANAGEMENT (OCRWM) OFFICE OF QUALITY ASSURANCE (OQA) SUPPLIER SURVEY OQA-SFE-97-001 OF HUESSER NEWEIGH (HN)

The survey of HN was performed January 20-21, 1997, at their Clayton, California, facility. The survey criteria is delineated in the OCRWM Quality Assurance Requirements and Description Document, Revision 5, and resulted in the issuance of ten recommendations. The recommendations, as noted in the enclosed survey report, are being provided to Lawrence Livermore National Laboratory for corrective action.

The conditions identified during the survey, and specified in the recommendations, would require restrictions on the use of this supplier for the calibration services provided. Prior to providing calibration services for OCRWM, HN must satisfactorily address all noted recommendations. Determination of acceptability rests with the Civilian Radioactive Waste Management System Management and Operating Contractor subject to verification by the OQA.

The survey is considered complete and closed as of the date of this letter. Resolution to the recommendations will be evaluated by the OQA, as appropriate.
