TSC Group, Inc. is conducting an investigation of potential environmental issues related to the following sites:

Jeffrey City, WY 82310

We request that a search of your records be conducted to determine if any files exist for the above mentioned sites. We are particularly interested in the following documents:

1. NRC administrative record
2. Permits (current and past), permit modifications and amendments, and permit applications concerning Western Nuclear, Inc.'s and/or Phelps Dodge's, or other owner/operators management of wastes or hazardous substances or materials.
3. Compliance reports or evaluations relating to the site's operating permits (including air discharges, wastewater discharges, surface water and groundwater discharges, etc.), any operating permits associated with the facilities, as well as any reports or memoranda discussing corrective measures implemented or to be implemented in response to such reports or evaluations.
4. Incident or release reports, including follow-up reporting and regulatory review.

5. Regulatory agency orders, Notification/Notice of Violations (NOVs), Notices of Deficiency (NODs), consent orders or agreements, imminent and substantial endangerment orders, injunctive orders, corrective action orders, and cleanup and abatement orders.
6. NRC and subcontractor reports on the following:
 - a. Facility assessment and/or facility investigation reports;
 - b. Field investigation results;
 - c. Risk assessments (ecological and human health);
 - d. Feasibility studies and/or corrective measures studies;
 - e. Treatability studies and/or corrective action plans;
 - f. Waste characterization reports;
 - g. Monitoring program reports (e.g., ground water or surface water);
 - h. Interim remedial or removal actions plans or reports;
 - i. Comments on any of the above mentioned reports;
 - j. NRC comments on such facility submissions; and
 - k. Facility response to NRC comments.
7. All documents that constitute a notice of claim, complaint, or other documents commencing a claim or suit against the facilities
8. Remediation decision documents (e.g., RODS).
9. Budgets for past, current and projected environmental removal action and remediation costs, and any other documents supporting projected environmental remediation or response costs.
10. Press releases concerning facility-specific environmental matters.
11. NRC internal memoranda and emails discussing facility-specific environmental issues:
 - a. Facility visits;
 - b. Notes from meetings or telephone conversations with environmental regulatory agencies, fire departments, health departments, or similar agencies at the local, state or federal level;
 - c. Progress reports;
 - d. On-facility removal and remediation costs; and
 - e. Environmental audit reports and any documents discussing or reporting any corrective measures undertaken in response to such audit reports.
12. All correspondence (sent and received) concerning environmental matters at the respective facilities.
13. Reports of incidents of spills or releases at the sites and subsequent response actions and investigations.

Once it has been determined that the agency has documents pertaining to the above-mentioned sites, we would like to schedule an appointment to review the documents at your offices.
