OFFICE OF CIVILIAN RADIOACTIVE WASTE MANAGEMENT (OCRWM) QUALITY ASSURANCE (QA) SUPPLIER SURVEY OQA-SFE-97-002 OF FTI ANAMET IN SUPPORT OF THE YUCCA MOUNTAIN SITE CHARACTERIZATION PROJECT AT LAWRENCE LIVERMORE NATIONAL LABORATORY (LLNL)

Enclosed is the report of OCRWM QA Supplier Survey OQA-SFE-97-002. The survey was conducted by the Office of Quality Assurance at Hayward, California, during the period of March 25-26, 1997.

The survey team determined that the quality controls being implemented by FTI Anamet were being implemented in a satisfactory manner.

During the course of the survey, two (2) recommendations were identified requiring FTI Anamet's action. In addition, it is recommended that a restriction be placed on the user of FTI Anamet's services to require the identification and submittal of the job package and associated calibration certifications of the Measuring and Test Equipment used. This restriction will be noted on the Qualified Supplier List upon receipt of LLNL's concurrence on the Supplier Evaluation Report.

The survey is considered complete and closed as of the date of this letter. The recommendations, as noted in the report, are being provided to LLNL for action.
