PURPOSE: The purpose of this Regulatory Conference is to discuss a preliminary White finding (a finding of low to moderate safety significance) and associated apparent violation of Technical Specification 5.4.1. This issue involved the failure to properly lock open Condensate Prefilter Vessel Bypass Flow Control Valve CNM-FCV200, resulting in a loss of feedwater flow following a September 18, 2002, reactor scram. This issue was described in NRC Special Inspection Report 50-458/02-07, dated February 7, 2003, (ADAMS accession No. ML030410114), and in a letter dated May 2, 2003, (ADAMS accession No. ML031220453).
