Dear Ms. Yowell:

In accordance with the task order procedures of the subject contract, this letter definitizes Modification No. 7 to Task Order No. 34. Modification No. 7 revises Section 6.0 - Scope of Work of Task Order No. 34 by adding the following efforts:

"The contractor shall also assist NRC staff in resolving and dispositioning public comments received during the rulemaking period and, if necessary, participate in meetings with NRC staff to resolve the public comments. This assistance shall be provided on an as-needed basis when requested by the TPM."

Referencing your December 16, 1999, E-mail, the above revision does not impact the cost ceiling for Task Order No. 34. Therefore, the task order ceiling amount \$196,252.00 remains the same. In addition, the period of performance, July 10, 1998 through July 22, 2000, does not change.

No funds are being obligated under this Modification No. 7.


