Overall the record is an acceptable distillation of the May 14, 2003, conference call. However, the conclusion of the first full paragraph on Page 4 of the record (especially, the last sentence) needs to recognize the cautionary note presented in Item No. 2, Page 2. If such results were to be used for the final status survey, then the data must be obtained in a manner that satisfies all related data quality objectives (DQOs) and be collected using procedures that meet DQOs that will be described in the DP. The NRC staff generally agrees with such a conceptual approach. However, SCA needs to recognize that this work was/is conducted at risk since it has not yet submitted the DP nor presented a set of DQOs to the NRC for review. Accordingly, the staff reserves the option of commenting on the approach and its implementation in the DP.
