
Gentlemen:

**Reasons and Justifications**

**Change**

**Pages Affected:** Pages throughout the Physical Security Plan, the Safeguards Contingency Plan, and the Security Training and Qualification Plan.

**Change:** The title of Security Shift Lieutenant Operations has been changed to Supervisor Security Operations. The Supervisor Security Operations reports directly to the Manager Security.
