SUBJECT: REQUEST FOR TECHNICAL DATA

The Division of High-Level Waste Management of the U.S. Nuclear Regulatory Commission requests the following technical data that is resident in the Yucca Mountain Project Office ARC/INFO-INGRES data base. All the requested data are listed in the GENESIS Data Dictionary (the "meta" data for the data listed in the Technical Data Catalog) and are referenced in Appendix D of the 12/31/92 issue of the Technical Data Catalog and the Supplements (no Data Tracking Numbers [DTNs] are associated with these data).

In general, this request is for all the base map information (spatial data) for the Yucca Mountain area. Specifically, such data as the following are being requested:

- ARC/INFO topographic data (processed USGS DEM)
- Mapping information and references, benchmarks, survey reference points
- All existing field investigation and instrumentation locations (coordinates x,y,z), with accompanying ID information, e.g.
 - all well locations (groundwater, neutron, etc)
 - all biological study locations
 - all ecological sampling locations
 - all pit and trench locations
 - all rain gage locations
 - all runoff gaging site locations
 - all surface sampling sites
 - all soil sampling sites
 - all vegetation sampling sites
 - all meteorological stations
 - all air quality sampling sites
 - all infiltration plot/test sites
 - all groundwater recharge stations
- All proposed field investigation and instrumentation locations with accompanying ID information.

 - Perimeter outline (x,y,z) of the proposed repository
- Remote Sensing
 - Orthophoto (most recent low altitude aerial photography of the Yucca area, 10" x 10" stereo prints)

These data are for loading the data base of the Division of High-Level Waste Management's Advanced Computer Review System which will be using ARC/INFO & EarthVision to view and manipulate the data for the license review process. For all the requested data except the aerial photos, please copy the digital data files to the enclosed 8mm Data Cartridge (Tape number NRC YMS-0001, 1 GB capacity) with ARC/INFO export files command and return by express mail.
