ORDER

Pursuant to 10 C.F.R. § 2.730, the NRC staff has requested clarification and/or an extension of the time in which to file its response to the State of Utah's Petition for Review of LBP-03-08. The staff explains that language in LBP-03-08 leaves ambiguous whether the staff's response is due on June 23, 2003 or June 26, 2003. The staff requests that the Board's decision be construed to afford the staff until June 26, 2003 for its response. The staff further notes that it has discussed this request with counsel for both the State of Utah and the applicant and that neither object.

Pursuant to my authority under 10 C.F.R. § 2.772(b), I hereby grant the staff's request. Accordingly, the staff's response to the State of Utah's Petition for Review will be due on June 26, 2003. The same deadline will apply for any response by the applicant, Private Fuel Storage.
