The U.S. Department of Energy (DOE) has recently received the results of Phase I reviews for the following:

- 2. Study Plan 8.3.1.3.2.2, History of Mineralogic and Geochemical Alteration of Yucca Mountain" (Reference 2).
- 3. Study Plan 8.3.1.5.1.2, "Paleoclimate Study: Lake, Playa, and Marsh Deposits" (Reference 3).
- 4. Study Plan 8.3.1.2.2.3, "Characterization of Percolation in the Unsaturated Zone-Surface-Based Study" (Reference 4).

In transmittal letters for these reviews, the following request is made for each study plan in the second paragraph of each letter, "The NRC staff requests that the procedures, methods, and other relevant details be provided to NRC for its review as soon as that information is available."
