Dear Mr. Holonich:

The Office of Civilian Radioactive Waste Management (OCRWM) has responsibility to determine whether or not the Yucca Mountain site in Nevada is a suitable location for a repository for disposal of spent reactor fuel and high-level waste. Fulfillment of this responsibility will involve acquisition of data concerning the site's physical characteristics and interpretation of the data to make findings concerning suitability of the site for waste disposal.

Data acquisition at the site has been underway since the 1970's. In 1985, available data were used to prepare an Environmental Assessment for the site, and in 1988 the then-current data base was used to prepare the Site Characterization Plan.

In 1990, to implement goals established by the Secretary in 1989, OCRWM set as its objective to evaluate, as soon as possible, whether or not the Yucca Mountain site is suitable for disposal. Also, OCRWM developed a strategy to focus data acquisition and utilization on meeting this objective. As part of this strategy, a current baseline site evaluation was to be made. This baseline would be used to focus and prioritize future data acquisition activities and to provide a foundation for resolution of technical issues concerned with site evaluation.

This letter transmits, for your review and comment, the contractor baseline site evaluation, "Report of Early Site Suitability Evaluation of the Potential Repository Site at Yucca Mountain, Nevada (SAIC-91/8000)." This contractor report is accompanied by a document which compiles the comments of the members of an independent peer review panel which assessed the baseline Report.


