On June 9, 2003, Fuel Cycle Safety and Safeguards, Division of Waste Management, and Office of the General Counsel staff met with representatives from Western Nuclear, Inc. (WNI) in Denver, Colorado. This meeting was at the request of WNI to discuss its March 7, 2003, Supplemental Groundwater Modeling Report, Red Mule area issues, and surety issues.

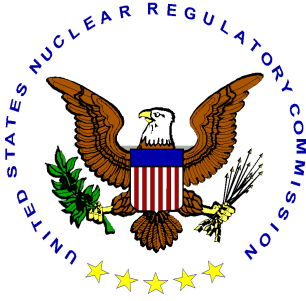
