We have completed our technical reviews of the proposed Certificate of Compliance (CoC) No. 1004, Amendment No. 5, the proposed Technical Specifications (TS), and the preliminary Safety Evaluation Report (SER) for the NUHOMS®-32PT storage system. The proposed changes to the CoC, including the TS, are indicated by vertical lines on the margin. The change proposed for Amendment No. 5 includes the addition of a canister designated as the NUHOMS®-32PT. It is designed for use with the existing NUHOMS® Modular Storage System and NUHOMS® transfer cask.
