DEFENSE WASTE PROCESSING FACILITY (DWPf) TECHNOLOGY EXCHANGE AND
SITE VISIT

The Office of Civilian Radioactive Waste Management (OCRWM) has issued the Waste Acceptance Preliminary Specifications (WAPS) for the DWPf. This document outlines the minimum acceptable requirements for the DWPf waste form to be acceptable for disposal in any of the three potential federal repositories. The NRC met with the Department of Energy in July and December 1986 to discuss the waste acceptance process activities and obtain additional information related to the Waste Acceptance Specifications.

As part of DWPf technology transfer at the last NRC meeting, a request was made to visit the DWPf site. Accordingly, arrangements have been made to allow access for the NRC, States, and Tribes with specific interest in waste acceptance. The meeting has been scheduled for April 22-23, 1987 at the Department of Energy Savannah River Operations Office (SR). It will be necessary for all participants to be identified by name, social security number, and citizenship no later than April 10, 1987. The point of contact at SR for meeting attendees is Ken Chacey, (803) 725-1372. An agenda for the meeting is enclosed and has been coordinated with your staff. The Office of Geologic Repositories, OCRWM will make the appropriate notification of the subject meeting with the States and Tribes.
