

**Re: Clarification on Reciprocity Filing**

Ms. Villar:

On December 16, 2002, Integrated Environmental Management, Inc. (IEM) submitted an application to perform activities in a non-Agreement state. At the time of filing, we indicated that work would begin on February 1, 2003 and end on April 1, 2003. Because the duration of on-site work during that period was only 10 days, we filed a clarification on April 1, 2003. However, the work that was scheduled for June has been delayed. Therefore, we would like to make the following changes to our application showing a total usage of 40 days for CY 2003:
