The Committee was briefed by the NRC staff on their plans to reevaluate and implement the standards through rulemakings and conformance of Part 60 to the EPA standard. The Committee also had the benefit of discussions with representatives of DOE and EPA.

2. <u>Program Plan for the Advisory Committee on Nuclear Waste (ACNW)</u> (Report to Chairman Carr, dated December 29, 1989).

The Committee provided a program plan for ACNW activities during the four-month period of January through April 1990.

3. <u>Hanford Waste Tanks</u>

During the briefing on EPA standards, Mr. Bernero noted that a petition for rulemaking is expected regarding identification and separation of the waste contents in the tanks. Mr. Bernero requested that the Committee consider this matter at the appropriate time and agreed to provide the related correspondence to the Committee.
