PREPARATION OF A STATEMENT OF PROFESSIONAL QUALIFICATIONS

The purpose of this memorandum is to request that each of your technical staff prepare a Statement of Professional Qualifications using the guidance given in the enclosure. This is the format that is used when providing testimony during the hearing process. In preparing the statements, a short narrative of work experience along with any special training should be included. Each branch should maintain its own statements as well as provide a copy to Anne Garcia who will maintain a division-level file.

The Statement of QuaTifications is to be written in first person and go chronologically backwards from the most recent work experience. Please ensure the statements are prepared by May 31, 1990. The statements will be used when staff are giving presentations, such as presentations to the Advisory Committee on Nuclear Waste, and will help us in our ongoing efforts to ensure staff are receiving adequate training and experience to ready them for an eventual licensing hearing.
