Pursuant to 10 CFR 50.54(p)(2), Dominion Nuclear Connecticut, Inc. (DNC) is submitting revised pages to the Physical Security Plan for Millstone Power Station, that are associated with Revision 45 (Attachment 1). This plan revision became effective May 22, 2003. A description of the changes is provided in Attachment 2. We have determined that these changes do not decrease the safeguards effectiveness of the plan.
