Enclosed are an original and a copy of a U.S. Department of Energy (DOE) letter to the Advisory Committee on Nuclear Waste (ACNW) in which DOE proposes a process for scheduling interactions and suggests topics relative to the Office of Civilian Radioactive Waste Management (OCRWM) for presentation to the ACNW.

The original DOE letter is for your consideration and for subsequent referral to the ACNW. The letter copy is for your retention and recordkeeping.

The purpose of the letter is to offer a means for planning and scheduling interactions in a similar manner as they are arranged between DOE and the U.S. Nuclear Regulatory Commission (NRC). Both proposed processes--for suggesting topics and for scheduling those meetings--are based on a balancing of OCRWM knowledge of the present issues of priority and current Departmental budget for participation in meetings.
