SUBJECT: ADDITIONAL CDSCP REVIEW WORK TO FINALIZE CDSCP DRAFT POINT
PAPERS BY APRIL 22

With respect to your recent memo to me providing HLTR recommendations for additional CDSCP review needed to finalize the draft point papers, I note that Figure 1 of the APP, which allowed for a ten week period of workshops with DOE and issuance of final point papers by May 20, has been used for scheduling and planning purposes. As was discussed in the February 24 HLTR-HLOB Section Leader meeting, at which we requested your recommendations for additional work, as well as in various discussions between HLTR and HLOB staff, the deadline for finalizing the draft point papers has been changed to April 22 in recognition of our not holding 10 weeks of NRC/DOE workshops. At the request of the HLTR Section Leaders in the March 16 NNWSI team meeting, I am hereby putting the April 22 date in writing. You may consider this to be a formal change to the APP.

Please reconsider the HLTR recommendations for additional CDSCP review work in light of the April 22 date, and indicate what work must be completed by that date to finalize the draft point papers and what resources will be required to accomplish that work in the time allotted. I will appreciate your response by COB Tuesday, March 22.


