SUBJECT: FORMAL REQUEST FOR CDSCP REVIEW AND SPECIFIC CHANGES
TO THE CDSCP ADMINISTRATIVE PLAN AND PROCEDURES

The purpose of this memorandum is to formally request support from HLTR for the review of the CDSCP and issue specific changes to the Administrative Plan and Procedures (APP) related to team assignments, schedule, and PPSAS numbers. As we discussed, the review will be principally conducted by the Nevada team listed on enclosure A and their TA contractors with some limited support from other staff members. This list is a minor revision to Table 7 of the APP. Staff CDSCP review time should be charged to PPSAS no. 411612, title: Review Consultation Draft SCP - Tuff. Enclosure B gives the dates for the review milestone shown in figure 1 of the APP. We recognize that this schedule is uncertain after February 19, 1988, since we are continuing to discuss our workshop plans with DOE. These plans should be firmed up in the next two weeks.

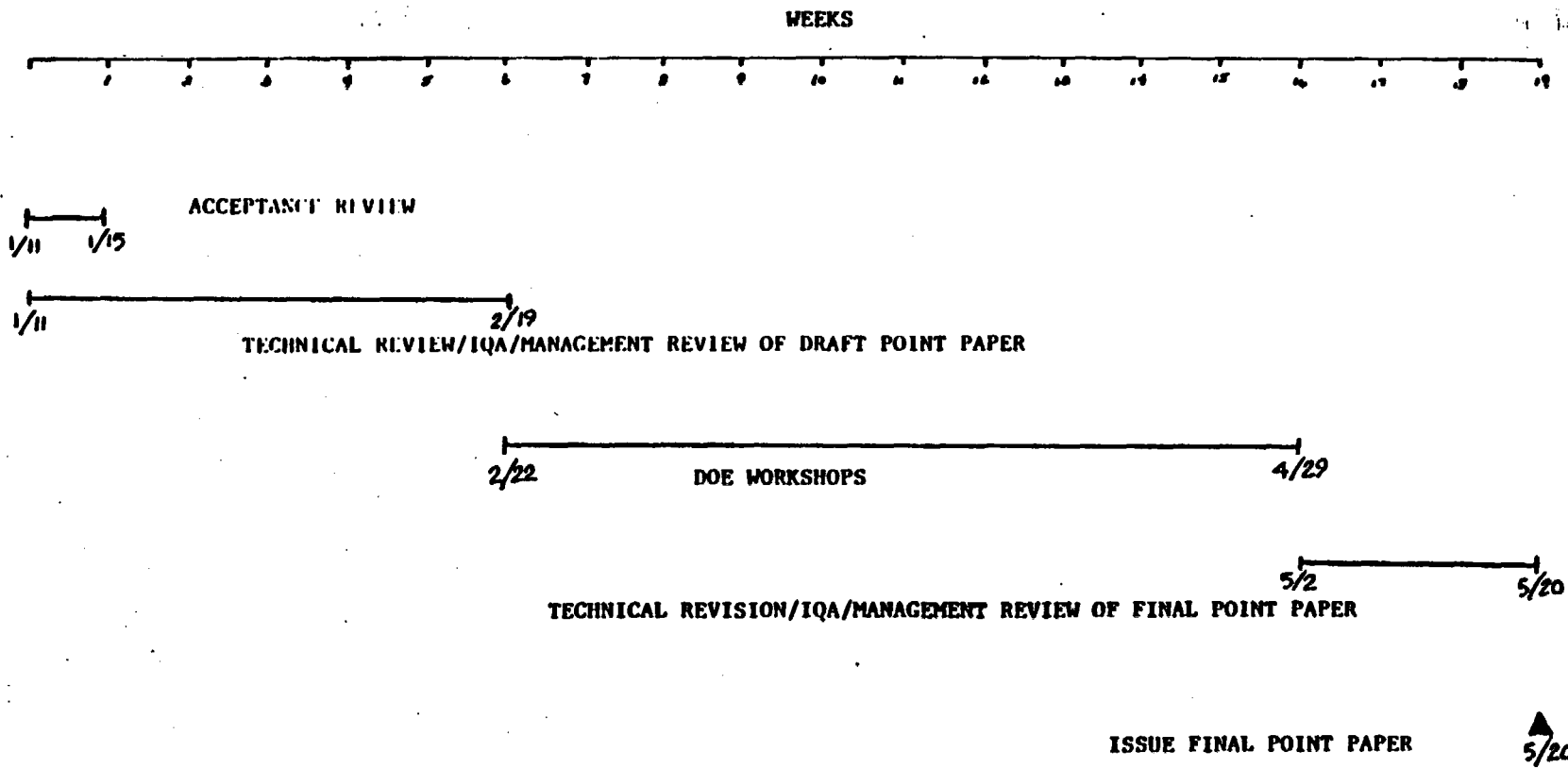
