Dear Mr. Vogt:

We have reviewed the monthly letter progress report for April 1986 and have the following comments.

The computer magnetic tape containing the source code for codes benchmarked by GeoTrans was received. It my understanding from telephone conversations with you that the delay in completing the GeoTrans report arose from the need for including tables of results as well as graphs. Please advise us as to the status of the preparation of tables.

NRC's comments on the draft final Radiological Assessment Code benchmarking report were provided by letter and markups dated May 27, 1986. Please advise us whether our comments and those from the external QA reviewer will demand major revisions.

As we discussed at our meeting on June 9-10, the NRC will not be able to obtain the code ADINA84. Hence, only the problems which can be completed using the older version of ADINA need be completed by Acres.

The action taken by this letter is considered to be within the scope of the current contract NRC-02-81-026. No changes to cost or deliver of contracted products are authorized. Please notify me immediately if you believe this letter would result in changes to cost or delivery of contract products.
