SUBMITTAL OF REVISION 6 TO THE PHYSICAL SECURITY AND SAFEGUARDS  
CONTINGENCY PLAN**

**Ladies and Gentlemen:**

In accordance with 10 CFR 50.54(p)(2), Progress Energy Carolinas, Inc. is providing Revision 6 of the Physical Security and Safeguards Contingency Plan for the Brunswick Steam Electric Plant (BSEP), Unit Nos. 1 and 2. 10 CFR 50.54(p)(2) states, in part, that the licensee may make changes to the plan without prior NRC approval if the changes do not decrease the safeguards effectiveness of the plan. The licensee shall maintain records of changes to the plan made without prior NRC approval for a period of three years from the date of the change, and shall submit, as specified in 10 CFR 50.4, a report containing a description of each change within two months after the change is made. The changes described in this submittal were effective on June 26, 2003.

A summary description of the changes is provided in Enclosure 1. Enclosure 2 provides a summary of the evaluations of the changes that demonstrate the changes do not decrease the safeguards effectiveness of the Physical Security and Safeguards Contingency Plan.

A copy of the revised Physical Security and Safeguards Contingency Plan is provided in Enclosure 3. Enclosure 3 contains safeguards information that requires protection in accordance with 10 CFR 73.21. When separated from Enclosure 3, the cover letter, Enclosure 1 and Enclosure 2 are decontrolled.
